SUPREME NOD, BUT...

... Green clearance a must for Balbharati-Paud Phata road project, rules SC

he long-delayed Balbharati-Paud Phata road project has finally received the green signal from the Supreme Court on Wednesday, on the condition that the Pune Municipal Corporation obtain environmental clearances for the stretch passing through Vetal Tekdi before work can begin.

The proposed road is intended to ease traffic congestion near the Law college and Karve Road. The PMC's road department has been planning the route for several years, but environmental groups had opposed it and filed petitions in the Bombay High Court as well as in the Supreme Court.

Three months ago, the high court dismissed a petition filed by Nagarik Chetana Manch and lifted the stay on the project, offering partial relief to the PMC. The petition, which was pending in the Supreme Court, was heard by a bench comprising Chief Justice Bhushan Gavai and Justice Vinod Chandran.

The 2 to 2.25-km stretch between Balbharati and Paud Phata along the Bhandarkar institute and will cut through Vetal Tekdi, triggering objections from social organisations.

The road is seen as a vital alternative route to decongest Shivajinagar and Kothrud, but sustained opposition from environmental activists has caused significant delays. PMC's

legal team, led by Solicitor General Tushar Mehta, informed the court that the project cost has escalated sharply due to the prolonged litigation.

The PMC's legal officer, Nisha Chavan, confirmed the directive and said further details would be available once the court order is received.

The civic body's legal representation included Solicitor General Tushar Mehta, and advocates Abhijit Kulkarni, Rahul Garg, Dhaval Malhotra and Nisha Chavan, The petitioners included Dr Sushma Date and ILS Law College.

Key objections and legal disputes

- Environmental concerns: Activists have pointed out that the proposed alignment passes through the green belt of Vetal Tekdi, threatening large-scale tree cutting and habitat disturbance
- **The petitioners:** Citizens' group Nagrik Chetana Manch, environmentalist Sushma Date, and others have filed petitions against the project in both the high court and Supreme Court
- **Committee's observation:** The Central Empowered Committee (CEC) has categorically stated that the area falls under a deemed forest and has recommended halting the construction
- PMC's stand: The PMC maintains that the road will be built using flyover-based

technology designed to minimise environmental impact and avoid harm to the hill

- Threat to biodiversity: Environmentalists warn that the project could affect local flora, fauna, and groundwater levels within Vetal Tekdi
- Ecological imbalance: Cutting through the hill to construct the road could disturb the ecological balance, they argue
- Alternative solutions: Activists also contend that proper traffic planning and improvement of existing routes could eliminate the need for this new road

Govt to dish out ₹43 cr for schools in Pune, other Maha districts

fter months of delay, the Maharashtra State Education Department has finally sanctioned R under the Pradhan Mantri Poshan Shakti Nirman Yojana (PM Poshan) for providing midday meals in schools.

The department has approved 43.09 crore for meal expenses and 38.41 crore for cooks' honorarium to be distributed among all districts $\,$ in the state, including Pune.

For the past few months, schools across Maharashtra, including several in Pune, had been struggling to provide midday meals due to shortage of funds. Some schools managed to continue serving meals using their own resources, while at other institutions, teachers personally contributed to ensure students did not go hungry.

The Midday Meal Scheme covers students from Classes 1 to 8 in government, aided and local body schools. Under the scheme, students from Classes 1 to 5 are to receive meals providing 450 calories and 12 grams of protein, while

those from Classes 6 to 8 should get 700 calories and 20 grams of protein daily.

However, due to the delay in funds allocation, many Pune schools had not received any money for the past four months. This has made it difficult to purchase essential supplies like vegetables, fuel and other cooking material, bringing the meal service to the brink of suspension.

Announcing the long-awaited relief, director of primary education, Sharad Gosavi, issued a circular confirming the release of funds. According to him, cooks and helpers will receive Rs 2,500 per month as honorarium for ten months with the central government contributing Rs 9.22 crore and the state government Rs 29.19 crore.

Since schools have been uploading daily meal data online, payments have been processed directly through a computerised system based on district-level requirements. Accordingly, Rs 43.09 crore has been released to various districts.

The decision has brought major relief to schools in Pune, ensuring the smooth resumption of nutritious meals for thousands of students. School management committees, teachers, and parents have welcomed the move, while expressing hope that funds will now be disbursed regularly and without delay in the future.

Bitter pill... er, syrup!

he recent spate of incidents in Madhya Pradesh and Rajasthan have once again exposed the fundamental shortcomings of the Indian pharmaceutical industry. They have now come to the fore in a deadly form. In just a few days, at least 22 children lost their lives to poison hidden in a bottle of cough syrup. Investigations found that the syrup contained industrial chemicals like diethylene glycol and ethylene glycol in lethal quantities. Both these compounds have no use in medicine; they are industrial chemicals and when ingested, they cause kidney failure and death. No one would dare to say that the pharmaceutical companies. whose sole aim is to make money, did not know that these chemicals are poison for children. But still, looking at the history of such cases so far, the chances of serious action being taken against such devils seem a little low.

Similar Indian medicines caused child deaths in Jammu in 2019, Gambia in 2022, and also in Uzbekistan. The question is why did this happen again? More importantly. why has responsibility not been fixed so far despite such serious errors clearly coming to light? Will it be fixed now or not? India introduces itself to the world as the 'Pharmacy of the World'. One in five generic medicines used worldwide are manufactured in India. We supply vaccines and medicines to more than 150 countries. If such a country cannot guarantee safe medicines for its own children. then this is not just a failure of the system, but a very serious crime against human life.

Suspicion is being cast on companies like Srisan Pharmaceuticals, Rednex Pharmaceuticals and Shape Pharmaceuticals after the deaths. The amount of DEP in Srisan Pharmaceuticals' Coldriff Syrup was found to be 480 times higher than the limit. The question is, how was such a dangerous syrup produced even after the government introduced a strict export inspection policy in 2023? Were the reports fake? Was there collusion in the laboratory tests? Or did regulators turn a blind eye? These questions need to be answered.

The pharma industry needs strict enforcement more than laws. We have a global drug code that is being brought into line with global standards for drug manufacturing, but what is the use of the code if the same rules are not followed? Weak monitoring mechanisms, inadequate laboratories, and political interference by state governments have all strangled the public health system. At the root of this chain is a lack of accountability. Drug companies, laboratories, regulatory authorities, and doctors all shirk their responsibilities in this chain. As a result, innocent children are losing their lives.

What India needs today is strict action and transparency. Merely fining the guilty companies will not suffice. Their licences of the companies found guilty must be cancelled permanently and criminal cases registered against the responsible officials. The way forward is to increase the number of drug inspectors, digitise their work, and implement a tracking system for each drug batch. If this is not done, we should be prepared to lose our children in the same way.

JUSTICE DELAYED, AND DENIED

Senior citizen leaps to death from Shivajinagar court building after 27-year legal fight over family land

ustice delayed is justice denied. But for 61-year-old Namdev Jadhav, a resident of Wadkinaka, Hadapsar, the delay proved fatal. This senior citizen, who was fighting a property case for the past 27 years, allegedly took his own life by jumping from the fourth floor of the Shivajinagar District and Sessions Court building on Wednesday morning.

The tragic episode occurred around 11:45 am at the new building court premises, a bustling building that sees thousands of litigants and advocates every day. The incident has reignited public debate about the human cost of India's judicial delays and the crushing backlog that continues to paralyse the justice system.

According to Senior Inspector of Police Mahesh Bolkotgi of Shivajinagar police station, "Jadhav reached the court premises early in the morning. Despite not having any hearing scheduled that day, he managed to enter the new court building and reached the fourth floor, where staff members were occupied with cleaning and administrative work. It is suspected that he climbed through an open section of the terrace and jumped from the top."

He added, "There was a safety

tin sheet barrier, but Jadhav reportedly broke through it due to the impact, falling directly to the ground floor. The sound of the fall alerted nearby court staff and lawyers, who immediately rushed to the scene."

Another police officer said Jadhav was found lying unconscious in the court compound and was immediately shifted to Sassoon General Hospital, where doctors declared him dead on arrival. The police later took custody of the body for a post-mortem examination.

Suicide note points to frustration over 27-year-old case

The Shivajinagar police, led by Senior Police Inspector Mahesh Bolkotgi, are investigating the incident. A two-page suicide note, dated October 15, 2025, was recovered from the spot.

The police confirmed that the note contained the case number of Jadhav's long-pending civil dispute, which reportedly dates back to 1998. "He wrote that he was tired of waiting for justice and that all his attempts to get his rightful share had gone in vain. He felt helpless because the matter had dragged on for decades without resolution," said an officer.

The note also bore Jadhav's signature and details of his ancestral land dispute, suggesting deep emo-

tional and financial strain.

According to Deputy Commissioner of Police (Zone 1) Krushikesh Rawale, the deceased had been entangled in a bitter property dispute involving his siblings, which is mentioned in his suicide note, but the police said they are probing the facts. "As per the suicide letter, there was litigation between Jadhav and his brother over ancestral land in Hadapsar. Their father had sold part of the property without Iadhav's consent. and the remaining portion was occupied by his brothers, who later constructed houses there. Jadhav felt wronged and had approached the court seeking his share. However, the case continued for nearly three decades without any conclusion," Rawale explained.

The officer added that Jadhav was reportedly living alone and suffered from depression. "He did not have any court date on Wednesday. People who knew him described him as a disturbed person. We are verifying all facts mentioned in his note and cross-checking with court officials about the status of his litigation," Rawale said.

Probe into security and court access

The police have begun preparing a preliminary report in coordination with the court administration to understand how Jadhav gained access to the terrace area. The Regional Forensic Science team rushed to the spot to probe the case and collect the evidence. The court's security staff is being questioned, and CCTV footage is being scanned to reconstruct his movements inside the building.

Sources from the court complex said that the fourth-floor terrace area was generally restricted, but certain maintenance doors had been left open that morning for cleaning work. A staff member, on condition of anonymity, said "We heard a loud sound and rushed outside. It was horrifying. No one expected something like this to happen inside the court premises."

Debate over system

The suicide has sparked outrage among lawyers, activists, and litigants who say the incident reflects a larger systemic crisis — where delayed justice has become a norm rather than an exception.

Pune Times Mirror's investigative report, "Justice Denied?" (September 28 edition), had highlighted the growing pendency of cases in Pune courts. As per the latest data from the National Judicial Data Grid (NJDG) updated on October 15, 2025, Pune courts currently have 7,74,117 pending cases — comprising 1,86,492 civil and 5,87,625 criminal matters.

Of these, nearly 6% (43,914 cases) are filed by senior citizens, who often struggle to attend hearings and bear legal expenses. For

many, justice remains out of reach within their lifetime.

On Wednesday, among the senior citizens who approached the court, 85-year-old Savitrabai Agane said, "I lost my husband five years ago and my brother had promised to give me ancestral land. They procured my thumb impression on some legal documents and later did not give me any money. I sold fish and then came to court for my hearing but the court gave another date. It's just date on date."

Sukhdev Waghmare (72) has a litigation concerning a housing society. He said, "Since 2009 I am struggling with justice as I am a member of the society committee. I am paying the expenses from my own pocket. I am coming regularly for the court case. And just getting date after date."

Senior Adv CV Joshi said, "While the pandemic years worsened pendency, the real issue lies in chronic vacancies of judges, inadequate infrastructure, and procedural inefficiencies."

Senior advocates practising at the Shivajinagar court described the tragedy as a "wake-up call" for the judiciary. Adv Vivek Bhargude said, "A 27-year-old case is practically a lifetime. For litigants like Jadhav, every adjournment adds emotional trauma. If the system cannot deliver timely justice, it is effectively denying justice."

Another advocate added that courts urgently need psychological counselling cells and helplines for distressed litigants. Adv Lalit Jhunjhunwala said, "Legal stress is real. People spend years chasing hearings, paying lawyers, and waiting endlessly. The government must understand that judicial pendency is not just a number — it is human suffering,"

Authorities to review safety protocols

Following the incident, the District Court administration has begun preparing an internal report

on safety protocols and access control inside the court premises. Officials have also indicated that the Bombay High Court's administrative wing may take cognisance of the incident and seek a detailed inquiry into the circumstances.

The police have informed Jadhav's family and are verifying the authenticity of the suicide note. The investigation is ongoing.

Meanwhile, among the corridors of the Shivajinagar court, a haunting question lingers — how many more lives must be lost before the wheels of justice finally move faster?

RAPPED, MOLESTED & IGNOR

Woman screamed for help at a busy junction in Wagholi, **but Pune looked away**

he city that boasts the titles of Maharashtra's cultural capital and educational hub failed a woman in distress. She was being molested inside an autorickshaw in the busy Wagholi area during peak evening hours, crying for help as commuters hurried past, choosing to ignore her screams. However, one man stepped

forward to help her, but what followed exposed the deep systemic flaws in how such crimes are handled.

While many such incidents of molestation go unreported, those that do surface often fail to get justice. The incident occurred on Tuesday, around 9 pm near Wagholi Chowk, a busy, noisy intersection clogged with honking vehicles, flashing lights and restless commuters eager to get home. Amid the chaos came a sound that should have stopped traffic, the desperate cries of a woman in distress.

But no one stopped.

Inside one autorickshaw — registration number MH14JP6619 — a young woman was allegedly being molested. Surrounded by hundreds, she screamed for help. And yet, Pune stood frozen in indifference.

Only one man chose to act

Rahul Khandelwal, Chief Operating Officer of Weikfield Foods Pvt Ltd. was on his way home when he heard the cries. "At first I thought it was a quarrel." he later recounted. "But the screams grew louder, terrified and desperate. I knew something was very wrong."

He and his driver, Kailash, scanned the traffic and saw the source of the desperate screams. A rickshaw with its blinds drawn. As they got closer, the headlights of nearby vehicles revealed what was happening inside.

Rahul, stopped his car in the middle of traffic, ran across the road, and pulled aside the rickshaw's blinds to confront the two men. Inside, the girl was trembling, her clothes torn, as she tried to compose herself. "She said she didn't know them. She was weeping uncontrol-

lably and pleading for help," Rahul told Pune Times Mirror. "The girl was struggling. The man beside her was touching her, restraining her, molesting her. He had grabbed her by the shoulders, blocking her exit and refusing to let her go, while the autorickshaw driver sat unmoved," he said.

While others watched or worse ignored, Rahul held onto the auto's side bar, threatening to take the men to the police. His driver, Kailash, rushed to assist. Amid the chaos and confrontations, they finally helped the girl break free and run across the road to safety. Within minutes, the men fled the scene. No one else moved. No one else helped.

Only money matters

When Rahul had confronted the autorickshaw driver, demanding to

know how he could sit still while a girl was being assaulted in his autorickshaw, the driver's response was as chilling as the crime itself. With complete indifference, he shrugged and said, "Mujhe kya, mera bhada chal raha hai." Those words: Why should I care? I'm getting my fare, lay bare a deeper sickness in our society. The casual detachment, the moral numbness that allows violence to unfold in full public view while everyone, including those close enough to stop it, simply look the other way. "Those cries were loud enough for anyone to hear," Rahul said. "If I could hear them from a car several feet away, what about those closer? People just see... and move on."

Systemic failure

When Rahul called the women's helpline (112), he was met with bureaucracy.

"They kept asking for my name, my number, where I live while the accused were escaping," he said. Even when the incident was reported to the Wagholi police, the response was procedural, requiring the victim herself to lodge a complaint. A rule that, in effect, allows many perpetrators to simply melt away into the night. What happened at Wagholi was not just a crime, but a mirror held up to Pune.

Once a city known for its social consciousness, activism and youthdriven energy, Pune's reaction last night was chilling in its silence. People recorded videos, scrolled through their phones, rolled up their windows but did not step out.

Where was the outrage that should have erupted? Where was the instinct to protect? Every city has its heroes, but a society that needs heroes for basic humanity has already failed. This is not the Pune that once stood up for causes. that prided itself on education and awareness. This is a city that watched a woman being assaulted in plain sight and decided it wasn't its problem.

The police procedure, too, raises questions. Why must the victim. traumatised and terrified, be the one to initiate the complaint? Why can't immediate action be taken based on a credible eyewitness report?



For rabies-free city

RFID chips to help PMC monitor three lakh stray dogs

n a new approach to strav dog management, the Pune Municipal Corporation (PMC) has launched a pilot project to implant RFID microchips in stray dogs for ensuring tracking and curbing rabies. The initiative was inspired by successful models in Delhi and Jaipur and marks a major technological shift in the city's approach.

The civic body's veterinary department has begun tagging 600 stray dogs with RFID microchips embedded under the skin. These chips will store key data, including health status, vaccination and sterilisation records, and location history, enabling instant

access and monitoring.
According to the PMC estimates, Pune and its suburbs are home to roughly 2.5 to 3 lakh stray dogs. This includes 32 newly added villages under PMC limits.

In the past few months, the city has recorded 7,850 dog attack incidents, 45 per cent of which involved children. Rabies cases have also

risen by 12 per cent.

Tech-driven tracking

Under the pilot project, RFID microchips are inserted during vaccination or sterilisation procedures. Each chip stores age, colour, and gender of the dog; dates of vaccination and sterilisation; location: and details of the attending veterinary staff.

The chip allows instant retrieval of data, helping authorities monitor health, migration and population trends with greater accuracy.

The PMC has installed scanner machines and computer systems to support the initiative.

Similar projects

Similar projects in Delhi and Jaipur have yielded positive results, including: accurate stray dog population counts; significant progress in rabies control: improved sterilisation and vaccination coverage; and easier tracking of migrating dogs.

Shelters inadequate

Court guidelines mandate that stray dogs be housed in shelters for feeding, vaccina-

tion and sterilisation. However, the number of shelters is inadequate. Fights and injuries among sheltered dogs pose additional challenges.

As a result, the more practical and effective approach is to capture, vaccinate, and sterilise dogs, then release them back to their original locations. Microchip technology enables precise tracking and record-keeping for such dogs.

Annual target

The Government of India has set a target of 'Rabies-Free India' by 2030. The PMC has set an annual target of sterilising and vaccinating at least 70,000 stray dogs. Currently, the city has only three permanent veterinary centres, and more are needed to meet this goal.

Veterinary officer Dr Sarika Funde said, "Monitoring dog health is vital to realise the goal of a rabies-free Pune. Microchip technology offers a long-term and effective solution." She added that the pilot could serve as a model for other major cities across India, promoting the use of advanced technology in managing stray dogs.



Third phase of school campaign begins

he third phase of the state-wide 'Mukhyamantri Majhi Shala, Sundar Shala' (Chief Minister My School, Beautiful School), campaign is set to launch for the academic year 2025–26, with new initiatives and revised evaluation criteria.

The competitive programme, aimed at holistic school development, has

received an overwhelming response in its previous two phases and the School Education Department has now begun preparations for the next stage, which will include participation from schools across the state, including Pune.

An allocation of Rs 86.73 crore has been made for this phase. According to the School Education Department, the third phase will introduce fresh concepts and updated benchmarks. A formal proposal was submitted to the state government by the Commissioner of Education on August 29, 2025.

For 2025–26, the third phase will include new evaluation methods and activity modules. Schools will be assessed based on quality, taking into account their geographic and social context.

BID TO REDUCE DEATHS

Govt hospitals to submit info of patient fatalities; state aims to analyse data, take steps

n order to reduce the patient mortality in public hospitals, the state government has decided to analyse the deaths at these hospitals. Towards this end, public hospitals will be required to submit detailed medical analyses to the government, specifying the exact cause of each patient's death. This will enable the state government to carry out in-depth analysis of factors such as the number of deaths in public hospitals, patient age groups, medical history, and more data.

Senior administrative officials from the Department of Public Health, Medical Education, and Research have confirmed this development. Although hospitals have so far maintained records of deceased patients at an institutional level, the government is now taking a more serious approach — analysing this data collectively to identify actionable insights aimed at lowering mortality rates.

Following the tragic deaths of children in Madhya Pradesh and Rajasthan due to consumption of contaminated cough syrup, both public and private healthcare sys-



tems have come under scrutiny. In response, the Food and Drug Administration (FDA), in collaboration with the state government, is re-examining the availability and quality of medicines. Strict directives have been issued to all health agencies to prevent such incidents in Maharashtra. Experts have also highlighted that this extensive data will help determine which medicines are effective for specific illnesses and which are not.

Although individual hospital deaths are analysed, a state-level understanding of these patterns is essential. As a result, each public hospital in the state is now required to

fill out a Google Form with comprehensive information on patient deaths. A committee will collectively study the data gathered through this initiative.

Learning from experience

During the COVID-19 pandemic, the mortality analysis committee's studies helped hospitals enhance the quality of care. They discovered patterns such as higher death rates during specific time frames and among particular age groups. One key finding was that most deaths among critically ill patients occurred at midnight, prompting changes in shift

schedules for better service delivery. The availability of data on which medications were most effective for symptom-based treatments also proved useful. It is expected that the new, more in-depth analytical approach will further support such improvements.

Incomplete implementation of HMIS

The Hospital Management Information System (HMIS) was introduced for public hospitals three years ago, but it is yet to become fully operational. At present, it functions only at the Outpatient Department (OPD) level, serving limited purposes like retrieving and recording case papers. There is no detailed documentation of inpatients' medical history within the hospitals.

To fully implement HMIS in major public hospitals — including those in Mumbai — between 700 and 1,000 computers are required. While around 100 computers have been supplied to some hospitals, many remain unused due to lack of connectivity. Some hospitals are also facing network issues. As a result, due to the incomplete rollout of HMIS, there is currently no comprehensive recording of a patient's journey from admission to discharge.

CET Cell to verify documents

Infiltration of out-ofstate students in Maha MBBS admissions

erious questions have been raised over the integrity of Maharashtra's medical admission process after it emerged that several students from outside the state have allegedly secured seats in the ongoing MBBS admission rounds. The third-round registration list has revealed names of candidates from Rajasthan, Jharkhand, and Uttar Pradesh, some of whom are reportedly already admitted to prestigious institutions such as AIIMS yet still appear in Maharashtra's merit list. Following these revelations, the State CET Cell has initiated verification of the documents of such students and has sought their original certificates for scrutiny.

The incident has sparked outrage among Maharashtra's medical aspirants, who allege that their rightful seats are being unfairly taken by outsiders through fraudulent means. Student organisations have condemned the episode as 'direct attack' on local students' rights, citing poor transparency, lax verification, and technical irregularities in the admission process. According to preliminary reports, nearly 60 students from other states are suspected to have submitted fake domicile certificates claiming to be residents of Maharashtra to gain admission under the 85% state quota, which is reserved for local candidates. The remaining 15% seats are allotted to students under the All-India and NRI quotas.

Shockingly, several of these students are already enrolled in medical colleges through the All-India quota or in their home states but have simultaneously registered for admission in Maharashtra. This has raised suspicions of an organised admission racket involving middlemen or agents. Many of these candidates do not meet Maharashtra's domicile criteria, leading to widespread anger among parents and legitimate candidates. Student unions have demanded an immediate inquiry, cancellation of fraudulent admissions, and the filing of criminal charges against those found guilty. They have also urged the Chief Minister and Union Health Ministry to intervene without delay.

Student groups have gone a step further, demanding that such students be barred from pursuing medical education for at least five to six years, warning that those entering the profession through deceit may become 'unethical or criminal-minded doctors' in the future.

When contacted, Dilip Sardesai, Commissioner, State CET Cell, said, "We have instructed these students to email their original registration documents for verification. Time has been given for this process, as their names are already in the system. However, admission will proceed only after thorough verification of the original documents."

Ordinance for agri markets

Eight APMCs from Mumbai, Pune in the first phase

aharashtra Governor Acharya Devvrat has issued an ordinance amending the Maharashtra Agricultural Produce Marketing (Regulation) Act, 1963 to establish 'National Importance Markets" in the state. The ordinance, promulgated on October 13, lays the groundwork for a new structure of agricultural market regulation, under which government-appointed members will now be selected from the Konkan Revenue Division for the designated market committees.

Until now, 12 directors were elected to each Agricultural Produce Market Committee (APMC) from various revenue divisions. However, under the new ordinance, government nominees will be drawn exclusively from the Konkan division. In the first phase, eight out of the 51 APMCs across Maharashtra are expected to be included in this new framework. These are likely to include markets from Mumbai, Pune, Solapur, Nagpur, Latur, Sangli, Chhatrapati Sambhajinagar, and Kolhapur.

According to officials from the state's marketing department, while the legal changes apply to 51 of the 306 APMCs in Maharashtra, only eight committees will be prioritised for inclusion in the first stage of



implementation.

The ordinance specifies that markets with an annual turnover of not less than 80,000 metric tonnes — or an equivalent value as periodically notified by the government — and those sourcing agricultural produce from at least two states, may be designated as "markets of national importance." This effectively allows any existing APMC meeting these criteria to be upgraded to a national-level market.

Significantly, once a notification declaring a market as one of "national importance" is issued under Section 5-1(A) of the amended Act, the existing market committee will cease to function, and all current members will immediately vacate their positions.

The Maharashtra Gazette dated October 13, 2025, further notes that the Act empowers market committees to regulate and promote the purchase and sale of agricultural and allied produce in market areas, including private markets and farmer-consumer markets established across the state.

Uddhav Thackeray to inaugurate MNS's Diwali fest

t appears that Maharashtra Navnirman Sena (MNS) Chief Raj Thackeray's political stance is shifting for the upcoming Brihanmumbai Municipal Corporation (BMC) elections. In recent weeks, several developments have indicated a growing alignment between Raj Thackeray and Shiv Sena (UBT) leader Uddhav Thackeray. Adding to this perception, the Thackeray brothers are now set to share the stage at Shivaji Park for the MNS-organised Deepotsav (festival of lights). This marks the seventh meeting between the brothers in recent months, bringing a sense of optimism and excitement among the cadres of both parties.

In a symbolic gesture ahead of Diwali, Uddhav will inaugurate the MNS's annual Deepotsav celebration at Shivaji Park on October 17. The event, known for its grand lighting and festive atmosphere, has traditionally been a major attraction in Mumbai's cultural calendar. This year, however, its political undertones are unmistakable.

The renewed camaraderie between Uddhav and Raj Thackeray has sparked speculation in political circles about a possible alliance between Shiv Sena (UBT) and the MNS. Although Raj Thackeray has not made any for-

mal statement regarding such a tieup, Uddhav Thackeray has hinted on several occasions at the possibility of uniting the two factions. Their recent family interactions have further fueled speculation that the Thackerays could be moving toward political reconciliation ahead of crucial civic polls.

In a notable shift, this year's Deepotsav will see Uddhav Thackeray replacing Chief Minister Devendra Fadnavis and Deputy Chief Minister Eknath Shinde, who inaugurated the event in previous years. An invitation card circulating on social media confirms his presence as the chief guest, identifying him as the 'Shiv Sena Party President'.

The event is expected to draw prominent artists and political figures alike, but all eyes will be on the Thackeray brothers—whose reunion could reshape political equations in Maharashtra's most influential civic body election.

"As a temporary measure, we allow bursting of crackers from October 18 to 21," the bench said. "Crackers are smuggled into Delhi-NCR and they cause more damage," the CJI said.

He also claimed that there was

"complete chaos" in NDA, and it was still unclear which seats the BJP would contest and where the JD(U) wants to field its candidates.

"The situation is no better in the INDIA bloc either. There is a neverending tiff between RJD and the Congress. And nobody knows if former state minister Mukesh Sahani's Vikassheel Insaan Party is still by their side", claimed Kishor.

Meanwhile, in a significant development, Prashant Kishor has announced that he will not contest the Bihar assembly polls, a decision, he claimed, was taken by the party for its greater good. He also said a "tally of less than 150 seats" for Jan Suraaj will be considered a defeat.

Decisive blow to Naxals

Bhupathi's surrender weakens ideology, says Chhattisgarh Chief Minister

hhattisgarh Chief Minister Vishnu Deo Sai on Wednesday said the surrender of senior Naxalite Bhupathi and 60 other cadres in neighbouring Maharashtra's Gadchiroli district marks a decisive blow to the outlawed Naxal movement.

Naxalism, which challenged the country's internal security, is now on the verge of collapse and in its last leg of elimination, the CM said.

Senior Naxalite Mallojula Venugopal Rao alias Bhupathi alias Sonu and 60 other cadres surrendered in Gadchiroli on Tuesday.

In a post on 'X', Sai said, "Naxalism, which challenged the country's internal security, is now collapsing on every front and is going through its final stage. The surrender of 60 Naxalites, including the notorious Maoist politburo member Mallojula Venugopal Rao alias Sonu, in Gadchiroli is a decisive blow to the Naxalite ideology."

"Our valiant security forces are fighting this battle day and night with indomitable courage and are achieving success," he noted.

Sai said he has full faith that under the guidance of Prime Minister Narendra Modi and the leadership of Union Home Minister Amit Shah, the resolve to achieve a Naxal-free India by March 31, 2026, will surely be fulfilled.

"Chhattisgarh, especially Bastar, is now moving towards a new dawn of development and peace that has been awaited for years. Jai Hind!," he added.

Venugopal Rao, also known by aliases Bhupathi, Sonu and Abhay, and 60 other cadres, surrendered in Gadchiroli along with their 54 weapons, which include seven AK-47s and nine INSAS rifles.

So far this year, 253 Naxalites have been killed in separate encounters in Chhattisgarh, the most notable being the killing of Nambala Keshav Rao alias Basavaraju (70), the general secretary and top-most operative of the outlawed Communist Party of India (Maoist), and five central committee members.

According to the Chhattisgarh police, after the elimination of the Maoists' general secretary and eight central committee members this year and the surrender of Sujatha (also a CC member) and Bhupathi, now nine politburo and CC members (top Maoist operatives) are left in the banned outfit, including the dreaded Maoist commander Madvi Hidma from the state

Advocate Rishi Malhotra, who filed the petition, said at least an option should be given to a condemned prisoner as to whether he wanted hanging or lethal injection.

"I will demonstrate that the best way is lethal injection because 49 out of 50 states in the USA have adopted lethal injection," Malhotra said.

Crewed Moon mission by 2040: ISRO chief

Maiden human spaceflight to launch in 2027, reveals V Narayanan

SRO chairman V Narayanan on Wednesday said the space agency has set a target of landing Indians on the Moon by 2040, while its maiden human spaceflight mission 'Gaganyaan' is on track for launch in 2027.

Narayanan said a slew of ambitious space projects and sector reforms were currently underway, including a national space station by 2035, and three uncrewed 'Gaganyaan' missions by 2026, with the first one that includes a half-humanoid robot 'Vyommitra', targeted for December 2025.

"Prime Minister Narendra Modi has given a guideline for an indigenous crewed lunar mission by 2040, under which we have to land our own citizens on the moon and bring them back safely. A Venus Orbiter Mission (VOM) has also been approved to study the planet," Narayanan said in an exclusive interview with PTI.

The Indian Space Research Organisation (ISRO) chief said the Bharatiya Antriksh Station (BAS) is expected to come up by 2035, and initial modules in space are expected as early as 2027.

He was here to attend the 35th convocation ceremony of Ranchibased Birla Institute of Technology (BIT) Mesra as the chief guest.

"There are a lot of developments in 'Gaganyaan'. We are planning some more experiments. Before the crewed mission, we are planning three uncrewed missions. 'Vyommitra' is going to fly on that in December this year. Two more uncrewed missions will take place next year. Crewed 'Gaganyaan' mission would be possible by 2027 first quarter," Narayanan added. With Modi defining a clear roadmap and rolling out reforms for the space sector, ISRO is moving with confidence and clarity towards realising the dream of a self-reliant and vibrant space ecosystem, he said.

He said India's upcoming projects include Chandrayaan-4 and

Chandrayaan-5, a new Mars mission, and AXOM, a high-priority astronomical observatory mission.

"The Aditya-L1 mission has already yielded over 15 terabits of solar data, with valuable insights into coronal mass ejections and space weather," Narayanan added.

"We are open to international collaborations," he said, emphasising that while India is committed to self-reliance, climate science and space research, "how and where we collaborate will be debated and decided based on scientific and strategic priorities."

Narayanan said the space sector has been transformed through the Indian National Space Promotion and Authorisation Centre (IN-SPACe), which integrates startups and private players into the national ecosystem.






